




BUSINESS MODEL

Following a €1M funding round in 2022, the company is scaling its versatile VR solution, usable across various settings except ophthalmology and for children under seven. Active in over 200 institutions across France, Belgium, and Switzerland, Healthy Mind targets hospitals, nursing homes, workplaces, and independent professionals, with plans for broader European expansion.








SOLUTION MATURITY


Healthy Mind's solution demonstrates advanced maturity, with significant potential to drive changes in clinical practices. Supported by a multidisciplinary scientific committee, the solution has undergone several clinical studies, with additional research ongoing. While Patient-Reported Outcome Measures (PROMS) and Patient-Reported Experience Measures (PREMS) results are not yet published, the existing studies underline the solution's impact on reducing anxiety and pain. This robust scientific foundation enhances its credibility and adoption across diverse medical contexts.
